Harvey Lynn Elder, Ph.D. was a Professor of Mathematics at Murray State University for 45 years. He received his Ph.D. in Mathematics from the University of Illinois. He was a minister for the Church Of Christ for 60 years and most recently the minister of Friendship Church Of Christ near Murray, KY.

He was a member of several groups throughout the years including National Council Of Teachers Of Mathematics, American Mathematics Association, Phi Delta Kappa, Jackson Purchase Historical Society, in which he served as president from 1968-1969, and he was the current Chaplin of the Tilghman Beauregard Camp of the Sons Of Confederate Veterans. Dr. Elder was also a Kentucky Colonel.
